CANADA CONGREGATIONAL MISSIONARY SOCIETY FONDS. —1842-1926; (predominant 1899-1926). — -39 cm of textual records. — 1 microfilm reel : positive and negative

The Society was constituted in 1853, and held its first meeting in 1854; it was formed by the merger of the Congregational Union of Canada West Missionary Society and the Congregational Missionary Society for Eastern Canada. Its main responsibility was to give financial aid to churches and ministers in Canada.

Fonds consists of the following series: 1) Minutes of the Congregational Union of Canada West Missionary Society, 1842-1854; 2) Records of the Canada Congregational Missionary Society, 1869-1926, 3) Records of District Associations, 1837-1853.

SERIES 1: RECORDS OF THE CONGREGATIONAL UNION OF CANADA WEST MISSIONARY SOCIETY. — 1852-1854. — 4 cm of textual records. — 1 microfilm reel : positive and negative.

The Society was formed in 1842 to minister to settlers in remote areas of what is now Ontario. In 1853 it merged with the Congregational Missionary Society for Eastern Canada to form what became known as the Canada Congregational Missionary Society.

Series consists of manuscript minutes, 1842-1854; printed report (microfilm), 1844; printed report, 1849; and extracts from the proceedings of the Toronto Auxiliary, 1842-1854.

SERIES 3: RECORDS OF DIRSTRICK ASSOCIATION. – 1837-1853. – 3 cm of textual records.

The object of District Associations was to “promote the revival of spiritual religion; to secure closer union among the churches; to take counsel with each other in cases requiring it; to promote the interests of the churches associated in every way short of authoritative interference; and to unite in efforts to extend the Kingdom of Christ, together with the management of the missionary business within its limits.” District Associations worked out the objects of the Society in their respective localities; including the collection of funds.

Series consists of minutes of the Secretary to the Upper Canada Congregational Association 1837-1845; and annual meeting minutes of the Eastern Canada Congregational Association, 1846-1853.
