**EVANGELICAL UNITED BRETHREN CHURCH CANADA CONFERENCE FONDS. -- 1849-1988. -- 6.50 m of textual records. --30 photographs. --8 architectural drawings. --1 optical disc.**

The Evangelical Church Canada Conference was formed in 1864 out of the Evangelical Church New York Conference; originally there were nineteen ministers in what is now Ontario, mainly around the Kitchener (earlier Berlin) area, where the first station for German- speaking settlers was established. In 1946 the Evangelical Church joined the United Brethren in Christ to form the Evangelical United Brethren Church, with headquarters in Ohio. In 1968, the Canada Conference of the EUB consummated its union with The United Church of Canada. However, the Canada Conference Corporation continued to exist as a legal entity until 1988.

**SERIES 3: CONFERENCE SUPERINTENDENT/UNITED CHURCH OF CANADA HOME MISSIONS SUPERINTENDENT. – 1948-1975 (predominant 1966-1969) – 65 cm of textual records**

The Conference Superintendent's duties included having charge of all ministers and officials, and overseeing the spiritual and temporal interests of all churches in the district; changing and transferring ministers; inculcating the EUB Discipline; receiving information about church property/financial matters and helping with incorporation procedures. In 1968, when the EUB Canada Conference joined the United Church, Emerson Hallman became a Home Missions Superintendent and was given the responsibility of handling the transition of Canada Conference congregations to the United Church.
