METHODIST CHURCH (CANADA) ARMY AND NAVY BOARD FONDS. - 3.48 cm of textual records.

The Board was formed in 1915 and dissolved in 1919; its unfinished work was handed over to the Department of Evangelism and Social Service.

Fonds consists of correspondence, minutes, reports, and other records which document the Church's role in relation to military chaplaincy, recruitment, enlistment, conscription and exemption, moral condition of troops, demobilization and reconstruction. Statistical records and personnel files document war service of Methodist ministers, probationers, and laymen.

Box-File Box 1 contains a complete set of Minutes of the Army and Navy Board from December 1, 1915 to September 30, 1919: a total of 45 sessions. At first weekly meetings were necessary to deal with the business accumulated over the first year of the war and with current business. In time meetings became less frequent - even monthly meetings were not necessarily called. Box 4 contains the first set of Chaplains' Letters which are arranged alphabetically by the Conference to which the chaplains belonged. In the first file for each Conference is a rough list of the Chaplains whose letters were received or whose application was considered. Some letters are from applicants who were either turned down or who remained on the waiting list. The contents of the chaplains' letters vary in scope and volume according to the writer. Many contain detailed accounts of the chaplain's daily routine and his special projects; others, his problems and his achievements, his demands and his disappointments. The letters generally read like a personal diary of the Methodist Chaplaincy.

Box 12 contains the rest of the files on the <u>Chaplains' Fund</u>, and letters on the work proposed and later accomplished at the several <u>Military camps</u>. Chief among these for the Methodists was <u>Camp Borden</u> where the pastor of Angus, the Rev. C. W. Watch, doubled as camp chaplain, <u>ex officio</u>. Methodists were also involved in projects at Camp Whitley, at the <u>Soldiers' and Sailors' Home</u> at Esquimalt, B.C., and at <u>Camp Hughes</u>. Their greatest concern was that the soldier have a place where he could relax, write and take part in innocent recreation.

Box 14 contains the remainder of the files on the Military Service Act, and also a large number of files dealing with the question of the standing of ministers and probationers under the new regulations of the Act. Ministers were exempt, although the Manitoba clergy voted themselves non-exempt (File 316); probationers were not exempted as probationers, but were entitled to apply for exemption on the basis of their work that is, if it was essential to the well-being of the Church in a particular community. The Army and Navy Board as-sisted those probationers whose claims appeared to be valid, but the power to declare exempt rested in the hands of the Military Tribunals in each military district, and in the higher courts of appeal. The proportion of probationers seeking exemption was small in. comparison with those who enlisted for active service.

Box 15 contains correspondence on post-war measures dealing with probationers and ministers. The Army and Navy Board began an ambitious project: a compilation of <u>War Service Records</u> of all ministers and probationers who had served in the C.E.F. The result was a large volume of about 450 pages; 575 ministers and probationers are listed by Conference, although only 329 reports are written of them or by them. The compilation shows that 47 had died either in action, of wounds or other causes during the war; 20 withdrew or resigned from the ministry of the Methodist Church, Canada. Some of the reports are detailed accounts of the person's war career; most are merely sketches with a minimum of information. (File 346). The files numbering 347-352 contain corres-pondence on ministers and probationers on special subjects.

Box 18 contains the first of a lengthy series of files on Methodist Enlistment. Denominational enlistment figures in the period before con-scription showed a surprisingly small proportion of Methodists. The wording of the first attestation papers used "Wesleyan" instead of "Methodist," following usage in Great Britain; but other factors en-tered into the complex picture of Methodism's apparently dubious loyalty. To correct the public impression and for their own peace of mind, the Army and Navy Board, in the name of the Methodist Church, requested the Militia authorities to give them a copy of the enlist-ment papers for the whole dominion so that they could trace out en-listments of their own- people. The authorities declined on account of the expense of the operation. In December 1915, the Board sent out an explanatory letter to every Methodist minister in Canada, asking him to send the returns for his own circuit. Replies were scare and a month later a second letter was dispatched: half the circuits responded. Boxes 18-21 contain general correspondence on Methodist Enlistment and the replies to the first two letters.

Box 22 contains the circuit, district, Conference and national totals of Methodist Enlistments up to November 2, 1916. Also in this box are the files of responses to a third appeal (September 27, 1916) simply for the number of members and adherents who had enlisted up to the 31st of September, 1916. A slightly larger response showed that 38,201 Methodists had enlisted in 1,368 of 2,114 circuits. Almost as many had, therefore, enlisted from these circuits as the Militia Au-thority had reported for the whole of Canada.

Box 23 contains correspondence and papers on three different questions. Next to restoring honour to the Methodist name by statistical proof of loyalty the Methodist Church became deeply involved in Recruitment. (The Church, through its Army and Navy Board, requested information on the formation of new battalions, passed on promotional propaganda on appeals from the government, and organized the Church as much as possible as an agency for recruitment of volunteers for military service. Ministers often doubled as recruiting agents, some were officially appointed to that work by the government; and those who did not actively campaign for recruits were asked to fill in a confidential report of those in their communities eligible for military service. The pulpit also was used for vigorous challenges to those of military age. With the coming of conscription, the drive for recruits slackened and the Church took up its stand behind the new legislation. The Army and Navy Board acting on behalf of the whole Church was also concerned about the standard of Morality among the troops at home and overseas. They suspected it was not all that pure, and urged various resolutions on the government at home and in England to make the army safe from the corruption of drink, gambling and venereal diseases. Finally, this box contains the routine correspondence of helping individuals to find out about their boys overseas.

On December 30th, 1918, the Army and Navy Board issued a circular letter urging ministers to organize their people in Patriotic and War-Work Committees. Among other things the Board decided to take stock of Methodism's "full and glorious share in the war struggle"; for this purpose, three questionnaires accompanied the letter. The first dealt with numbers of men who enlisted from the circuit, the casualties and their dependents, and funds for the Army and Navy Board; the second asked for detailed information on the number of patriotic sermons preached on the circuit, the amount of money given for patriotic purposes and lists of articles donated to all kinds of war work; the third sheet was for the benefit of enlisted men and their dependents - a confidential report on their financial means and suggestions as to possible assistance. Such replies that came in were generally carefully detailed. The rest of **Box 27** contains these returns.

Box 28 contains letters and reports on <u>Demobilization and Reconstruction</u>. The Army and Navy Board was committed to a programme of assistance for integrating the soldier into civilian life, for the families of soldiers whose absence or death or disability meant a severe strain on the dependents, and for churches to help congregations .to adjust to the demands of a post-war society. The Board outlined its policy on reconstruction in July of 1919 (File 619). Notifications of returned and discharged soldiers were also officially received and noted by the Board. The Methodist Church through the Army and Navy Board provided unofficial 'chaplains' to meet and assist home-coming soldiers at the various dispersal areas across the country (Files 624 - 628).

Box 29 contains <u>General Correspondence</u> of the Army and Navy Board. A great variety of interests are mentioned: pensions settlements, soldiers' comforts, POW care, censorship, war service badges and many more. Of particular interest are the files on the Board's relationship with service groups such as the Y.M.C.A. whose work overlapped the Board's in some areas and whose personnel drew heavily from young Methodism. Numerous funds and appeals other than those of Methodism made application to the Board for sponsorship or endorsement (Files 671-678). Special Days also received attention from the Board for the promotion of par-ticular concerns: days of prayer and thanksgiving and repentance, and Re-establishment Sunday, to name a few (Files 679-684).

APPENDIX

The Army and Navy Board of the Methodist Church, Canada, was called into existence by the General Conference Special Committee Executive on November 23, 1915. And held its first meeting on December 1, 1915. The original membership of the Board was fixed at seven; namely,

Rev. S. D. Shown, D.D., LL.D. – Chairman Rev. T. Albert Moore, D.D. – Secretary-Treasurer Rev. Hiram Hull, B.A. Rev. J.A. Long, Ph.D. Hon. E.J. Davis Col. J.D. Chipman Mr. Oliver Hezzelwood

In May of 1918 four more members were added to the role: Capt., the Rev. John Garbutt, Rev. C.E. Manning, B.A., Mr. J.O. McCarthy, and Mr. Elmer Davis. Later in the same year Rev. W.B. Creighton, D.D., and Rev. R.N. Burns, D.D., appear as voting members. By action of the General Conference of 1918 the membership of the Board was officially increased to fifteen: Chown as Chairman along with seven ministers and seven laymen to be elected by General Conference on the nomination of the Committee on the Church, the War and Patriotism. In the fall a call was issued for a full meeting of the Board which was evidently to include representatives from the Conference of the Church. At this General Meeting of the Board (the first and the last) held on March 11-12, 1919, in Toronto, ten were present and three recorded as absent. The new members whose names then appeared were Rev. Ernest Thomas (representative of the British Columbia Army and Navy Board Committee), Rev. W.H. Barraclough (New Brunswick), Rev. W.H. Raney (Montreal), Capt. J.K Sparling and Prof. J.M. Trueman. The Board was thus more or less nationally represented with the notable exception of the prairie provinces (Capt. C.B. Keenleyside did, however, act as a delegate of the Board to Saskatchewan Conference).

In spite of the resolution to form Conference Army and Navy Board Committees only British Columbia Conference responded. In the Minutes of the Conference for 1916 the name of the Committee first appears consisting of six members. Rev. G.H. Raley acted as secretary for the Committee and was in correspondence with Dr. Moore shortly after the Committee was formed. As an auxiliary to the national board, the British Columbia Committee undertook similar activities and assisted in promoting the projects of the Army and Navy Board in the Conference area. Box 1, File 7 contains the correspondence of the secretaries concerning the B.C. Committee.

Nova Scotia had a long history of Army and Navy Committee work. In 1896 Nova Scotia Conference resolved the Methodists chaplains submit annual reports of their work; in the following year letters and reports from chaplains were included in the Minutes, and in 1898 a special Committee was set up specifically to report on Army and Navy affairs. By 1899 the Committee had become a permanent fixture. In the first wo year of the Great War, the Committee gave independent reports to the Nova Scotia Conference and another report appears in the 1917 Year Book, but it is doubtful that the Committee considered itself a branch of the Army and Navy Board of the General Conference.

New Brunswick and P.E.I. Conference Reports list an Army and Navy Committee in 1916 and 1917. The Bay of Quinte Conference resolved in 1918 that an Army and Navy Board Committee be constituted to rai the Bay Conference's allocation of \$3000 for the Army and Navy Board Appeal. There is no indication that it lasted longer than was necessary to raise the sum. London Conference constituted several committees having to do with concerns similar to those of the Army and Navy Board: 1916 Committee re Chaplains; 1917-1918, Committee on Ministers and Probationers on Military Service; and 1919, Honor Roll and Military Service Committee. Manitoba Conference named Dr. John Maclean as the Official Conference correspondent to Enlisted Ministers and Probationers (1917). Alberta Conference had similar Committees: 1917-1918, Committee of Letters Writers to Ministers and Probationers in Overseas Military Service: 1919, Committee re Historical Resume of our Military Brethren, and Committee re Returned Soldier-Probationers. None of the other Conference (Newfoundland, Montreal, Toronto and

Saskatchewan) list any committees with similar functions. Among the others only the B.C. Committee had a direct relationship with the Army and Navy Board for any length of time, but the work that Is reflected in the names of these other Committees indicates the response of the Conferences to the Board when called on for specific information and assistance.

The Army and Navy Board appointed its own committees to act from time to time. Specific committees mentioned in the minutes were: the committee on Finance, Employment of Chaplains, Consultation (while Dr. Moore was overseas), Itineraries, Methodist Enlistment, Future of Army and Navy Board, Education and Relation to the Federal War Services Commission.

During the first year of the war the Department of Social Service and Evangelism assumed responsibility for wartime duties and decisions of the Methodist Church. But by the winter of 1915 it was clear that a separate board would deal more effectively with military matters and with the wartime programme of the Methodist Church. The Army and Navy Board came into being in answer to the specific crisis, and when the armistice was signed and the Siberian adventure over the Board no longer had a continuing purpose. The last meeting was held on September 30, 1919, and any unfinished business became a concern from the Department of Evangelism and Social Service. The cycle was completed.

The duties of the Board were summarized under the following regulations contained in the First Annual Report of the Army and Navy Board (1916):

That each Methodist Chaplain be required to report to the Army and Navy Board on the first and third Monday of each month.

That the Army and Navy Board ... secure full particulars as to the present standing in the Army and official relation in the Church of all ministers and probationers who have enlisted and become combatants in the Army and Navy.

That the whole question of the conditions under which ministers and probationers shall be permitted to enlist as combatant officers or privates be referred to the Army and Navy Board.

That the Army and Navy Board be authorized to designate from time to time which of the Chaplains shall be Senior Chaplain and to define the duties of a Senior Chaplain.

That the Army and Navy Board be requested to arrange with each Chaplain to send letters from time to time to the Secretary, which will be edited and printed in the <u>Guardian</u> and Wesleyan.

That the Army and Navy Board be requested to give attention to the appointment of local Chaplains in the various cities and towns where soldiers are mobilized for training.

That the Army and Navy Board seek correspondence from ministers where men are stationed, giving information from time to time as to what is being done for the care of soldiers in their community.

That the Army and Navy Board shall endeavor to devise plans whereby Methodist families left at home while the wage-earner is with the Canadian Expeditionary Force shall receive careful consideration as to physical and spiritual needs.

That the Board shall also seek to devise means for the assurance of a welcome upon the return of soldiers from the front, and that efforts shall be made to secure adequate and suitable employment for such as require it.

The First Annual report also states: "To enable to Board to efficiently carry on its work, it was found necessary to open an office, furnish it with the required equipment and supplies, and secure a

stenographer." For the four years of the Board's operation its work centred at office #526 in the Wesley Buildings on Queen Street in Toronto where Dr. Moore and his staff, Miss Mildred E. Magee and Grace E. Woollings, processed the business of the Board. Miss Magee took charge of the office while Dr. Moore was absent on church business or on holidays in Muskoka. From this office poured a steady stream of correspondence.

Of great concern to the Methodist Church were the quests raised concerning the chaplaincy. Applications for chaplaincy appointments inundated the Board. A system had to be established for the administration and appointment of the Methodist Chaplaincy. One of the immediate reasons for the organization of the Board was that it might act as the official voice of the Methodist Church in consultation with military and government departments, especially as this concerned the chaplaincy. The appointment of chaplains was a military matter, and the Militia Department adopted an official procedure that would take into account the authoritative voice of the participating churches; in the case of the Methodists it was necessary for an applicant to have been recommended by the Army and Navy Board, and following the acknowledgment by the Militia Department to be approved by the Officer Commanding the particular Battalion needing a Methodist Chaplain. The number of Methodist Chaplains was regulated by the proportion of Methodists in the Services. On entering the service a Chaplin was assigned the honorary rank of captain unless his duties took on an executive nature at which time he might be promoted to the rank of major or of lieutenant-colonel. His orders came officially from his military superiors, although the Church maintained disciplinary control over all its appointees.

Although the Report of 1916 recommended bimonthly letters from every Methodist Chaplain the practice proved to be less ambitious. Some Chaplains were most indignant that they should be required to send home such time-consuming reports; others never realized that the Board required their regular correspondence; and still others made an attempt to keep up some sort of regular correspondence with the Board, but only as their own time and energy permitted. Boxes 5, 6, 7, 8, and 9 contain this correspondence along with some chaplaincy applicants' letters. The Army and Navy Board, although note responsible for the salary of chaplains, assumed responsibility for supporting their chaplains in many of their activities. Appeals were regularly issued from the Board calling for reading materials, special offerings for soldiers' comforts and individual self-denial for the extensions of the chaplains' services. A Chaplaincy Fund was organized by the Board to ease the personal debt of chaplains who purchased gifts for the comfort of hospitalized soldiers and sailors or who organized and sponsored camp activities and conveniences. The Army and Navy Board in cooperation with similar boards of the Presbyterians, Baptist and Congregationalist Churches published a Soldier's Booklet (see Box 13, File 293) which was prepared by Dr. Moore and was to be given to all men in the C.E.F. By the spring of 1917 the Booklet required two editions of 50,000 copies each.

The Army and Navy Board correspondence includes a wide variety of other subjects. A significant part is taken up with letters of sympathy from Dr. Moore on behalf of the Methodist Church to every Methodist family who had received reports of the wounding, death or missing in battle of a father, husband or son (Box 26). Letters continually arrives asking the Board from assistance in receiving a government pension or separation allowance, in gaining a promotion or a commission, in obtaining exemption or discharge or leave from military service (Box 24, 25). Toward the end of the war the Board made a thorough study of ministers and probationers who had serviced in the war, and complied a volume of war service records in which a page or more is devoted to each combatant or chaplain (Box 15, File 346).

The most ambitious project of the Board was the effort to secure an accurate estimate of the number of Methodists who had enlisted in the C.E.F. Periodic notices in the press and uncomplimentary comments by Church of England clergy tended to bran Methodists in Canada as unpatriotic and uncooperative in the crisis: all on the basis of unofficial denominational enlistment figures. These figures which had somehow reaches the press showed that Methodists recruits numbered between 30,000 and 35,000 by 1916, compared with 165,000 Anglicans, 70,000 Presbyterians and 51,000 Roman Catholics. The figures were denied by Ottawa, their records being in a state unsatisfactory for publication. Since the Militia Department declined to act on the Methodist Church's request for a survey of the troops according to denomination, the Army and Navy Board had but on alternative: to appeal to each circuit of the Church for

accurate figures. A form accompanying the appeal required complete information of each Methodist recruit. The results were far form encouraging as only a sprinkling of returns were received. A second and third appeal went out; by the publishing deadline for the 1916 Report barely half of the 2,050 circuits had reported enlistment figures. These returns showed that 38,201 Methodists had enlisted, and it was possible to estimate the national total at 65,000. By the end of the war the Army and Navy Board estimated that over 85,000 Methodists had enlisted. It is doubtful, however, that the vindication of Methodism was at all complete; the stigma once settled on Methodism was not erased by the attempt to provide accurate enlistment figures. Boxes 18, 19, 20, 21, and 22 contain the returns and the correspondence complied during this project.

The Methodist Church engaged freely in several schemes to aid the government in recruiting men for military service. Not only were ministers asked by the Board to report actual enlistments (for the project mentioned above) but they were also to include a confidential list of eligible men in their communities. The list would be passed on quietly to the military authorities as an aid for recruitment officers. Pulpits were frequently used for making impassioned pleas for national service (at the close of the war the Board sent a questionnaire to the circuits including the question, "Approximate number of patriotic sermons and addresses delivered by the present ministers of circuit on all circuits and elsewhere..."). Ministers often doubled as recruitment officers in their communities, and some Methodists were employed full-time in the capacity. With the passing of the Military Service Act of 1917 conscription replaced voluntarism and the Methodists Church officially supported the new legislation. The Manitoba Conference ministers even voted themselves non-exempt in an effort to be placed on the basis as anyone else in order that they might support the Act more authoritatively (Box 14, File 316).

The drive for recruitment also gave rise to a concern for those Methodists already in uniform who were in Training Centres, hospitals, Reinforcement Centres or in the tranches. The war did not slacken Methodist zeal for pure moral conditions among the troops. Pressure was applied on the Militia Department through the Army and Navy Board to cut off the rum ration and to ban the wet canteen which has appeared under British Command. Attempts were made to form an all-Methodist Battalion and a Dry Battalion (Box 23, Files 460-461). Even more alarming than the drink problem was the rise of the incidence of venereal disease. The Army and Navy Board vigorously campaigned against conditions in England that aggravated the situation; Dr. Chown's Report after his tour among the troops (Box 2, File 41) contains a section of documentation as to the gravity of the disease and its prevalence among the troops.

The Army and Navy Board was the natural channel through which service clubs and other organizations could make their appeals to Methodist people. The Most extensive correspondence of this nature concerns the Board's relations with the Y.M.C.A. which was popularly conceived as providing at times a more worthy service than the Church. Other correspondence reveals a less initiate association with clubs such as the Associated Kin of the Canadian Expeditionary Force, the Overseas Club and the Navy League of Canada. (Box 29, Files 659-667).

The Board sponsored special days and particular financial appeals. Quite naturally the Board urged Methodists to support the Army and Navy Board through its own fund, the Chaplaincy Fund and through the Sunshine Fund. Other appeals were endorsed from time to time, especially the Belgian Relief Fund, the Red Cross Appeal and Patriotic Fund, and the Victory Loan Appeal (Box 29, Files 670-678)

Demobilization and reconstruction made heavy demands on the Board. Dispersal areas for the returning troops required personnel; demobilized chaplains had to be provided for until Conference assigned them to a circuit; congregations had to be appraised of their responsibilities in welcoming the soldiers and in aiding in their readjustment to civil society. The army and Navy Board was also requested by General Conference to draw up recommendations, in association with the Department of Evangelism and Social Service, on reconstruction in Canadian society. The Report (the last major work of the Board), adopted by General Conference meeting at Hamilton in 1918, called for:

1. "a complete settlement of the world's political and military order as will be commensurate with the sacrifice made...

- "a system of production and service for human needs rather THAN solely for profit.
- 3. "national organization, national control ...national equality" essential to efficiency in the "nation of comrade workers."
- "a National Convention of the Churches of Canada for the consideration of the problems of reconstruction."

The last recommendation was consolidated by the active participation of the Methodist Church in the Federal War Services Commission of the Churches in Canada (Box 28, File 629) where the Protestant churches provided a forum for national Church policy on reconstruction.

The Army and Navy Board sought government assistance for the Methodists slider-probationers whose education had been interrupted by the war. The government agencies did provide some help, but the load fell mostly on the Board. In its last concentrated appeal, the Board raised funds sufficient to aid all who were in financial difficulties following their war service. The correspondence and records of the Repatriation Fund for soldier-probationers are contained in Boxes 16 and 17.

The Army and Navy Board of the Methodist Church, Canada was informally dissolved by September 30, 1919. Any unfinished work of the Board was continued by the Department of Social Service and Evangelism. Especially noteworthy in this respect are the files of the Department of the <u>Labour Church Movement</u> in western Canada (in which a number of prominent Methodist ministers were involved) and the files on the Federal War Services Commission of the Church in Canada.

Pulpits were frequently used for making impassioned pleas for national service (at the close of the war the Board sent a questionnaire to the circuits including the question, "Approximate number of patriotic sermons and adresses delivered by the present ministers of circuit on all circuits and elsewhere..."). Ministers

often doubled as recruitment officers in their communities, and some Methodists were employed full-time in this capacity. With the passing of the Military Service Act of 1917 conscription replaced voluntarism and the Methodist Church officially supported the new legislation. The Manitoba Conference ministers even voted themselves non-exempt in an effort to be placed on the basis as anyone else in order that they might support the Act more authoritatively. (Box 14, File 316)

The drive for recruitment also gave rise to a concern for those Methodists already in uniform who were in Training Centres, hospitals, Reinforcement Centres or in the trenches. The war did not slacken Methodist zeal for pure moral conditions among the troops. Pressure was applied on the Militia Department through the Army and Navy Board to cut off the rum ration and to ban the wet canteen which had appeared under British command. Attempts were made to form an all-Methodist Battalion and a Dry Battalion (Box 23, Files 460 and 461). Even more alarming than the drink problem was the rise of the incidence of venereal diseases. The Army and Navy Board vigorously campaigned against conditions in England that aggravated the situation; Dr. Chown's Report after his tour among the troops (Box 2, File 41) contains a section of documentation as to the gravity of the disease and its prevalence among the troops.

The Army and Navy Board was the natural channel through which service clubs and other organizations could make their appeals to Methodist people. The most extensive correspondence of this nature concerns the Board's relations with the Y.M.C.A. which was popularly conceived as providing at times a more worthy service than the Church. Other correspondence reveals a less intimate association with clubs such as the Associated Kin of the Canadian Expeditionary Force, the Overseas Club and the Navy League of Canada. (Box 29, Files 659-667).

The Board sponsored special Days and particular financial appeals. Quite naturally the Board urged Methodists to support the Army and Navy Board through its own fund, the Chaplaincy Fund and through the Sunshine Fund. Other appeals were endorged from time to time, especially the Belgian Relief Fund, the Red Cross Appeal and Patriotic Fund, and the Victory Loan Appeal (Box 29, Files 670-678).

Demobilization and reconstruction made heavy demands on the Board. Dispersal areas for the returning troops required personnel; demobilized chaplains had to be provided for until Conference assigned them to a circuit; congregations had to be appraised of their responsibilities in welcoming the soldiers and in aiding in their readjustment to civil society. The Army and Navy Board was also requested by General Conference to draw up recommendations, in association with the Department of Evangelism and Social Service, on reconstruction in Canadian society. The Report (the last major work of the Board), adopted by General Conference meeting at Hamilton in 1918, called for 1. "a complete settlement of the world's political

- and military order as will be commensurate with the sacrifice made...
- "a system of production and service for human needs" rather THAN solely for profit.
- 3. "national organization, national control...national equality" essential to efficiency in a "nation of comrade workers."
- 4. "a National Convention of the Churches of Canada for the consideration of the problems of reconstruction."

The last recommendation was consolidated by the active participation of the Methodist Church in the Federal War Services Commission of the Churches in Canada (Box 28, File 629) where the Protestant churches provided a forum V

for national Church policy on reconstruction.

The Army and Navy Board sought government assistance for the Methodist soldier-probationers whose education had been interrupted by the war. The government agencies did provide some help, but the load fell mostly on the Board. In its last concentrated appeal the Board raised funds sufficient to aid all who were in financial difficulties following their war service. The correspondence and records of the Repatriation Fund for soldier-probationers are contained in Boxes 16 and 17.

The Army and Navy Board of the Methodist Church, Canada, was informally dissolved by September 30, 1919. Any unfinished work of the Board was continued by the Department of Social Service and Evangelism. Especially noteworthy in this respect are the files of the Department on the Labour Church Movement in western Canada (in which a number of prominent Methodist ministers were involved) and the files on the Federal War Services Commission OF THE Churches in Canada.
