The Board of Evangelism and Social Service was established in 1926 at the time of union, bringing together Methodist and Presbyterian traditions in the field of social and spiritual welfare. The duties of the Board were broadly defined by the Manual of 1944 as giving "leadership to the Church...in the promotion of evangelism, the development of the spiritual life and work of the Church and the application of the Gospel of Jesus to the whole life" of the church and its adherents. This mandate was widely interpreted by the various secretaries of the Board: J.R. Mutchmor (served 1939-1962) promoted moral reform and temperance like the churchmen of an earlier generation, while J.R. Hord (1963-1967) took upon himself the task of preaching against the Vietnam War and promoting work with young American draft dodgers. W. Clarke Macdonald served as the last secretary of the Board (1968-1971).

In addition to promotion of the spiritual life through its publication of pamphlets and tracts, and later magazine advertisements, the Board was involved (directly or indirectly) in the operation of several facilities serving the needs of children, women, victims of alcohol abuse, young people, and the elderly. Another area of the Board's concern related to chaplaincy services in penal institutions and among troops in World War II, and it also had committees studying the role of the church in industrial society, rural society, and international affairs. In the 1960s and 1970s the Board became involved in social housing projects, human rights and racism issues, particularly as they affected Canadian native people, labour relations, medicare, abortion and aid to those opposed to the war in Vietnam.

In 1964 the Board became part of the Division of Congregational Life and Work but retained its own secretary and office staff. In 1972 it was wholly incorporated into the new Division of Mission in Canada.

Fonds consists of the following series: 1) Records of the Office of the Secretary, 1926-1978; 2) Records relating to departments of the work, 1932-1978; and 3) Research materials for reports, briefs, and statements submitted by the Board to the church and external bodies, 1951-1971, 4) Photographs, [192]-1973.

Scope and Content Note

The Board of Evangelism and Social Service fonds brings together the records of several institutions, committees, and office files relating to the proselitizing and social welfare work of the United Church. By far the largest amount of material in the fonds is given over to social service activities. In organizing and arranging the fonds, several previously independent groups of records have been tied together because of their ultimate relationship to the Board of Evangelism and Social Service. In addition, several previously undescribed records have now been organized, arranged and described in this finding aid. As a result, finding aid 127 offers researchers a convenient means of examining almost all the records of an important United Church of Canada body that had a significant impact on the field of social welfare across the country for nearly fifty years. Much of this social welfare activity continued through the Division of Mission in Canada into which body the Board of Evangelism and Social Service was absorbed in 1972.

SERIES 1: RECORDS OF THE OFFICE OF THE SECRETARY. - 1926-1971. - 2.2 m of textual records

Series consists of four sub-series: 1) Minutes of the Executive and Sub-executive, 1926-1939, 1947, and 1961-1971; 2) Correspondence files of the Secretary, 1926-1971, which deal with all the functional activities of the department, as well as the evangelistic and social service concerns of the department; 3) Subject files of the Secretary, 1925-1971, are concerned with social issues like temperance, the Vietnam War, and public morals; and 4) Circulars and letters, 1926-1970 are addressed to the clergy and membership of the church on social and spiritual matters.

This sub-series is complimentary to the second, and covers some of the same ground from a subject or topical arrangement. There is, however, no explicit connection between the two sub-series. While they bear a relation to the subject matter of the preceding series, researchers are cautioned, that is to say, researchers cannot hope to gather all materials related to any particular issue by looking at one or the other of these two sub-series--both should be examined (in addition, researchers interested in a topical approach should consider Series 3).

Records re Chaplaincy

Among the Board's many concerns was its interest in chaplaincy work. From 1960 the Board took an active role with other Church and government agencies in administering the work of chaplains in hospitals, industrial sites and penal and mental institutions. Although these files contain references to a number of immediate issues confronting chaplains (salaries, working conditions, relationships to authorities), much of this correspondence relates to the appointment, training and service of personnel. The minutes of various committees on which the United Church representatives served are also included.

Records re Public Morals

From 1940 the Board's Secretary monitored with increasing concern several issues fitting under the category "public morals". During the war years, moral conditions among Canada's troops were questioned and the incidence of venereal disease across the entire nation caused alarm. Opposition to gambling was expressed repeatedly and specific protests to lotteries, sweepstakes and raffles were registered. Rumors concerning the opening of a race track (with pari-mutual betting) north of Toronto also raised many questions.

The widespread influence of gambling, especially in the form of lotteries and bingo, remained a matter of concern to the Board throughout the 1950s. A major new enemy was confronted during the decade, however, as the Board grappled with the complex problems of drug addiction. Controls over television programming and the censorship of films were other issues addressed by the Board on behalf of the UCC. In 1957 Sunday editions of Toronto's Telegram focussed renewed attention on the question of Sunday observance. For 1958 the Board's foe was Peyton Place.

During the 1960s, gambling in its varied forms remained the Board's chief nemesis. Lotteries, food stamps and bingo each received critical notice but it was the race track which gained the Board's repeated opposition. The wagering of record sums of money, involving both on-track and off-track betting, was an obvious concern. With the introduction of Sunday racing in Ontario, the issue was extended to include the Church's witness to a proper observance of the Lord's Day.

Records re Temperance

This general heading includes an extensive collection of correspondence documenting the Church's repeated opposition to the increasingly widespread sale and consumption of beverage alcohol. The bulk of the material treats the period from 1938-1955. While the fact of "temperance" is included here, sentiments favouring prohibition and total abstinence often express the recognized ideal.

In the earliest correspondence, questions were raised regarding the liquor trade in Canada, the federal government's policies supporting the temperance cause and liquor traffic crossing the Canada-United States border. With the outbreak of war, of special concern was the apparently unrestricted availability of beverage alcohol to Canadian forces. The shipment of beer 15,000 miles to Canadian troops stationed in Egypt earned special criticism. And a temperance educational programme promoted by W.D. Bayley received attention, including Bayley's antagonism towards the United Church's temperance leadership.

From 1944-1946, the Board's personnel continued their careful scrutiny of the liquor situation in Canada. The federal government, along with various provincial agencies throughout the nation, was repeatedly questioned regarding its legislative programme with respect to the liquor trade and that trade's rapid expansion. The complex business interests of liquor magnates, notably E.P. Taylor and to a lesser extent Charles Bronfman, became a target of added attention. The Board's 1944 resolution suggesting the nationalization of the liquor traffic created concern and misunderstanding both inside and outside Church circles. This was followed in 1946 with the Church's introduction of a declaration or purpose card which advocated abstinence as "the wisest and safest course".

Ontario legislation permitting the introduction of cocktail bars dominated the Board's attention from 1947. While inquiries of a national nature were registered concerning liquor policies, the Board's lobby was focussed on Ontario and especially Toronto. The provincial government's liquor license board received constant questioning concerning the licensing and inspection of cocktail outlets. Numerous specific licenses were isolated for criticism. Meanwhile, provincial officials were contacted repeatedly with reference to the control of liquor advertising and the Secretary maintained his personal surveillance of E.P. Taylor's expanding business ventures.

The liquor situation in Ontario continued to be the Board's major concern during 1953-1955. Attempting to make its impact known, the Board criticized the liquor industry at every turn: its advertising, the operating hours of lounges and taverns, the expansion of the large brewing companies--even the sale of food items containing liquor extracts or flavours. The granting of licenses to scores of new Ontario outlets each year caused alarm, especially those received by social and athletic clubs. Toronto's proposed O'Keefe Centre created a storm of protest. In a matter touching neighbouring provinces, especially Manitoba, the Board voiced strong criticism of a CPR-CNR request seeking permission to serve beverage alcohol on the Ontario portions of their transcontinental trains. With the final months of 1955, attention shifted to Manitoba and that province's consideration of the Bracken Report.

From 1956 the Board's active opposition against the liquor industry began to fade. Two provincial protests were registered; in Manitoba during 1956, the Bracken Commission's Report was questioned, while in the

last months of 1957 the Board cooperated with temperance forces in Alberta during that province's plebiscite. It was increasingly clear, however, that the temperance issue was no longer the volatile subject it had been twenty years earlier. The fight had been waged and while some battles had been won, the war was lost. To the Canadian population at large, the case for temperance was simply a thing of the past. Liquor advertising—widespread, subtle and in the Board's opinion often grossly misleading—remained the one topic to ear the Board's repeated criticism.

Records re Vietnam

From 1965 until his death in March 1968, the Board's Secretary (J.R. Hord) voiced strong criticism of the American role in Vietnam. The earliest material documents the Board's official representations to federal authorities and also includes correspondence with other churchmen interested in the Church's witness in international affairs. The correspondence for 1966-1967 consists almost exclusively of responses to Mr. Hord's public statements concerning the war, American foreign policy and the moral obligations confronting the Canadian nation and its leaders.

Records re Welfare State

This collection includes correspondence and related material treating a broad range of topics which have been drawn together under the general heading "welfare state". Although the covering dates are 1932-1969, the bulk of the material deals with the 1940s and 1950s. Unemployment insurance, various federal and provincial health insurance schemes, family allowances and benefit for senior citizens are among the themes examined during the 1940s. In the following decade, several issues confronting the general welfare of Canadian society are discussed: unemployment and labour relations, the cost of living and inflation, aging, automation and the emerging role of women in the nation's labour force. It can be noted that actual Board correspondence is often not the dominant component of this collection. Newspaper clippings and other working papers (reports, bulletins) often comprise much of the material to be found in these files.

There is a great deal of research material found in the Board of Evangelism and Social Service accession which is not directly related to the activities of its various committees, or the operation of its various social institutions. An examination of the Minutes of the Executive and Sub-executive of the Board in the 1960s for example, will show that the members were interested in several issues that were either of an immediate nature (like the Vietnam War), or were not considered to be central to its mission as a vehicle for evangelism and social service (assistance to American draft resisters from that war who were resident in Canada). Examples of the use made of this type of material are found in the briefs presented by the Board, on behalf of the United Church, to Parliament on an issue like abortion; as background briefing materials for delegates attending a conference on racism and human rights; or for studies undertaken on issues like poverty or urban unrest. The collection of the research reports, newspaper clippings, statements from other denominations and non-

religious bodies was often undertaken for a period of time beyond the immediate need of it for a specific report, brief or statement.

Appendix 1

History of the Cedarvale School for Girls (includes content note)

In World War I, the Armenians pledged loyalty to the Turks; however, harsh Turkish requisitions and ill treatment of Armenian troops in the Turkish Army, caused friction. In 1915, alleging lack of loyalty, the Turks invaded Armenia and for three years attempted to deport the Armenian population to Mesopotamia and Syria. Furthermore, following the Greco-Turkish War of 1921-1922, thousands of Armenian women and children were herded out of their country. These schemes were carried out with unparalleled barbarity; American and Canadian missionaries who had been working in the area for a few decades were eyewitnesses to the tragic events and immediately organized help for the destitute survivors.

In 1915, Levon Babayan, an immigrant Armenian who had become very wealthy in the rug business, set up an Armenian Relief Association of Canada which attempted to set a means of bringing some of these Armenian children to Canada. In 1923, Dr. A.J. Vining was the secretary of this Association; he was most instrumental in obtaining the government's permission to bring one hundred Armenians into Canada. They were to be settled on a farm at Georgetown, Ontario. This farm was purchased in 1923 and under the supervision of Prof. A. Maclaren, and his assistant, Mr. Alexanian. Here the Armenian boys were to be given instruction in the techniques of farming, the English language, the three r's, and religion. In July of 1923, fifty Armenian boys from the Lord Mayor's Fund Orphanage in Corfu, Greece were brought to the 200 acre farm; in September of 1924, forty more boys immigrated from the same orphanage; in August of 1926, eight more boys arrived from a Miss Frearson's Home, Shemlon, Mount Lebanon, Syria.

For the first years of this project, all letters we possess centre around arrangements for the financial adoptions of the individual boys. By February of 1924, forty-two of the fifty lads were financially adopted. \$750 was asked for at the beginning, but Dr. Vining realized this amount would not be enough to cover the expenses of the boys for the necessary five year period, so each sponsor was asked to contribute \$1000 over the five year period 1923-1927. Many branches of the Armenian Relief Association raised funds in their local areas; many church groups, ladies groups, men's clubs, and some individuals adopted one Armenian lad and usually paid \$200 a year to the Relief Association. Dr. Vining resigned as secretary in December of 1924, and Rev. Ira Pierce, a missionary who had escaped from Armenia in 1918, succeeded him. Most correspondence from 1923 to 1927 deals with the problems of the finances for these boys. Each group was informed of the progress of their boy; some of the boys' names were changed at the request of some of sponsors, but the names were soon changed back to the original Armenian despite the difficulty in spelling; pictures of each of the lads were sent out to the sponsors; reminders of payments due are most frequent. There are several letters making arrangements for Rev. Pierce to speak or preach at different functions throughout the country; in addition, the lads sponsored several concerts especially in the first few years of their stay, and Rev. Pierce was responsible for arranging these performances.

The boys remained on the farm till 1925. In this year, it was felt that some boys were well enough adjusted to the Canadian way of life that the best policy now was to start sending the boys out into Canadian homes. They were trained for farm work, and many farmers agreed to employ each lad as a farm hand for one year. They were given room and board, and twenty-five percent of this amount was to be forwarded to the Board of Evangelism and Social Service and credited to the boy's individual bank account. At first, only a few lads were sent out, but by 1927, so many boys had been settled on different farms throughout Ontario, that letters of explanation had to be distributed to the sponsors; several stopped payments arguing that there was no further need of funds. Nevertheless the Association was still the legal guardian of each boy till he turned eighteen, and

sponsors were urged to continue support for the care of these lads (i.e. medical expenses). In October of 1927, ninety-one of the original ninety-eight boys were placed on farms.

In August, 1927, fourteen new Armenian boys arrived at the farm, so that as of September, 1927, there were only twenty-one boys remaining on the farm. That number was reduced to nine by December. In this month, sixteen Armenian girls were settled in Canada through the Association, as domestics in homes. Due to restrictions of the Immigration Department, no more boys could be brought into the country, and the need for this farm was being called into question.

Up till 1927, the Association had no official connection with anybody or any organization. Since no more boys could be brought to Canada, the Association entered negotiations with the newly formed United Church of Canada. At the end of this year, negotiations had reached the point where the Board of Evangelism and Social Service passed a resolution to conduct the farm at Georgetown. The Church agreed to meet the responsibility which the home had accepted for the proper care of the Armenian orphans, and furthered the purpose of the farm by proposing to establish Christian work for needy classes of people in Canada. There was some controversy about the sale of the farm and most correspondence at this time concerns the explanation of the transfer.

On January 12, 1928, the Armenian Relief Association of Canada transferred the responsibilities of the Association, along with the properties and physical assets of the Georgetown Farm, to the United Church of Canada, under the Board of Evangelism and Social Service.

The policy was changed at the beginning of that year also. The farm was now set aside for the care of and education of pre-delinquent girls. Mrs. Jessie Oliver was appointed Superintendent of the Ontario Home for Girls, and it was opened on May 18. It was hoped that thirty girls might be accommodated at the farm, but there was just enough space for thirteen. The age was limited to girls sixteen years of age and under. Rev. Ira Pierce stayed on as general secretary of the Georgetown Farm, and attended to different speaking engagements, and to establishing the legal age of the Armenian Boys. In January, 1929, there were still ninety boys under the age of eighteen and they were under the guardianship of the Board. On November 4, 1930, Rev. Ira Pierce was released and moved on to Montreal as secretary of the Quebec League Against Alcohol.

Up till 1928, 109 boys and 25 girls had been taken care of through the Armenian Relief Association of Canada. From 1927 to 1930, 32 Armenian Girls were brought over to Canada and settled in homes as servants. Several files of these girls are in our records, along with letters arranging their entry into the country and their hiring by different people.

In January, 1929, the farm was renamed, The Cedarvale School for Girls. By 1930, it was able to accommodate fifteen girls; they were taken from broken homes and for the most part recommended by the Children's Aid Society. During the depression no expansion of the services could be undertaken, nevertheless there was a constant flux of girls in and out of the school. During these years there were three staff persons in charge, The Superintendent, the Teacher, and the Housekeeper. In October, 1937, another wing was undertaken, and by 1938, twenty girls could be accommodated at the school. All during these years the farm, with its orchard and cattle, operated alongside the school, under its own committee, and managed by three men.

In the 1940's, the school looked after upwards of twenty-five girls, the average age ranging from eleven to twelve years. In 1944, Mrs. Jessie Oliver retired after twenty-six years as Superintendent of the School. She was succeeded by Mrs. Orpha M. Houston. In 1946, a large part of the farm land was sold; the orchard, the stocky and the barn were included in this sale. Space was expanded at the school to accommodate twenty-nine girls.

A new building was being planned in 1954, and it was opened on November 5 of the following year. Much correspondence focuses on this large undertaking. The old farm house was leased to an elderly lady who wished to start an Elderly Person's Home, but this folded in 1957 and the home was rented to a man who would do part time janitorial work around the new school. This new building would accommodate twenty-four girls; it was filled to capacity up until October, 1961.

In 1960, Mrs. Houston resigned, and Mrs. Phyllis Stobie followed her. She began to demand certain improvements within the school, its need for a social worker, psychiatrist, and more staff. However in October, 1961, there were only eleven girls at the school. This shortage of girls was felt by every such school right across the country; so in 1962, serious thought was given to the need for the school, and some thought it might be opened up to include boys. There were enough such institutions however, and this idea was turned down. Girls were accepted now on private placement, but numbers did not increase. By the end of the year it was decided that the work for younger girls could be closed out and that age group would not be left without care. There was a far more pressing need for work with older girls; greater professional services were required, however, and it was felt such a home should be centered in a city, in order to give more of an "in" feeling, as opposed to the "out" setting of the farm. The chairman of the Board of Evangelism and Social Service suggested that the Cedarvale School might become affiliated with the Boys' Village in Toronto, and his approach was adopted, with the hope that one or two units in the new property would care for disturbed girls. The Cedarvale School for Girls was closed on August 31, 1963, and turned over to the Board of Evangelism and Social Service to deal with as it saw fit. There was a hint that the building might be turned, into a Home for Unwed Mothers but this never came to fruition. In the following years, it was sold to the town of Georgetown and the property and building of the school was their centennial project; a recreation centre was developed at the site.

Appendix 2

Previous version of the Administrative history

Created in 1926, the United Church's Board of Evangelism and Social Service represented a merging of the similar boards from the Methodist and Presbyterian Churches. Under the supervision of Dr. Daniel N. McLachlan (secretary), five associate secretaries or field representatives directed the Church to the twin concerns of evangelism and social service. Of these associates, John Coburn (retired 1945) and Hugh Dobson (retired 1950) were especially prominent.

An associate secretary from 1936, James R. Mutchmor was named the Board's secretary in 1938 with his appointment, the Board's work was broadened extensively and its profile raised dramatically. A tireless crusader, Mutchmor was to become the Board's dominant figure, the Church's most visible official and one of Canadian society's most outspoken observers and critics. With the assistance of R.C. Chalmers (1944-1950), W.G. Berry (1947-1962), R.S. Christie (1950-1970), H.R. Lane (1951-1962) and G.B. Mather (1957-1968), Mutchmor led the Board in a vigorous protest against the erosion of the nation's Christian standards. Alcoholism and gambling were constant concerns; big breweries and the exponents of Sunday sport were traditional foes. Mutchmor argued on behalf of civil libertarians and organized labour; he questioned the government's licensing of cocktail bars; he monitored the results of pari-mutual betting and fought Peyton Place.

Mutchmor's successors were J.R. Hord (1963-1969), C.H. Forsyth (1968-1970) and W.C. MacDonald (1970-1971). Hord was especially prominent in prodding the Canadian conscience with regard to Vietnam and it was during his term in office that the Board's work was aligned with other Church agencies in a new Division of Congregational Life and Work. In 1971 the Board fell victim to another reorganization of the Church's national structure and effective 1 January 1972 its work was included in that of the new Division of Mission in Canada.

By Mutchmor's own account, about one-quarter of the Board's work was administrative; its larger task was functional. Administrative matters involved the supervision of two dozen homes and institutions serving the elderly, infirm and delinquent. The Board also undertook the editorial responsibility for a wide selection of devotional, moral and social literature.

The Board's greater energies were expended in an attempt to relate the Christian witness to a vast field of moral issues, social problems and the complex tensions of international affairs. In theory, the Board worked in close cooperation with its presbytery and conference conveners. Although these conveners were usually kept well-informed (and participated in the establishment of national policy and priorities), in actual fact the Board's performance was almost totally the performance of its Secretary and his associates.

Again, in name it was a Board of Evangelism and Social Service. In actual fact, throughout the Board's final two decades the tasks of evangelism rarely received more than token recognition.

Initial treatments of the Board's papers followed a topical scheme. That arrangement has been continued here in connection with the larger collections of correspondence: chaplaincy, public morals, temperance, Vietnam and welfare state. Each of these collections constitutes a distinct unit and these materials have been listed with accompanying descriptive paragraphs. All remaining correspondence has been arranged in strict chronological order as "General Correspondence". A descriptive paragraph indicating the subjects
